



# CONSENT & RELEASE

## (Use of Documentation from Events)

I acknowledge that OCAD University (“OCAD U”) and its authorized representatives create original video, photographs, podcasts and other materials (collectively, the “Materials”) that document a service or event provided by, or in association with, OCAD U (the “Event”, as listed below). I hereby grant to OCAD U, and its authorized representatives, the irrevocable right to produce, copy, reproduce, perform and publish the Materials that include an image, voice recording or other recorded likeness of myself, my minor child or ward or other party while I, or they, attend the Event. I further grant to OCAD U, and its authorized representatives, the irrevocable right to produce, copy, reproduce, perform and publish the Materials while maintaining the integrity of any Works captured in the Materials. The Materials shall, to the extent possible, identify you, your minor child or ward or the Other Party as the author of the Works. OCAD U shall, to the extent possible, obtain your, or your authorized representative’s, further written consent before modifying, altering or changing any images or recordings of the Works that are captured or incorporated within the Materials, in any manner.

I understand that OCAD U has the exclusive, world-wide, royalty-free rights, including all copyrights and moral rights, to the Materials created by OCAD U at the Event.

I waive any right to inspect or approve the Materials.

I understand that all use and sharing of the Materials by OCAD U is in adherence with OCAD’s Privacy and Information Collection Policy found at [www.ocadu.ca/privacy](http://www.ocadu.ca/privacy).

I further acknowledge that OCAD U cannot control unauthorized sharing, use or distribution of the Materials by persons other than OCAD U and its authorized representatives. I expressly release OCAD U and its authorized representatives from any and all claims I, my minor child or ward, or the Other Party may have for copyright infringement of the Works, or any other cause of action relating to OCAD U’s sharing, use or distribution of the Materials. OCAD U disclaims any responsibility for such unauthorized sharing, use or distribution of the Materials by persons other than OCAD U and its authorized representatives.
